
**Re: Commission Letter to Tom Marano re: Potential Use of Quote**

Dear Gary:

On behalf of JPMorgan Chase & Co., in response to the Commission's December 1, 2010 letter to Tom Marano, I write to object to the Commission's use of a purported quote from Mr. Marano's interview with Commission staff (the "Interview"). First, Mr. Marano has no recollection of ever saying that Mr. Cioffi was a "very popular fellow." Second, as the Commission is aware, there was no tape-recording made of Mr. Marano's interview, and the Commission's Memorandum summarizing the Interview does not reflect that Mr. Marano made such a statement about Mr. Cioffi. In short, we have no reason to believe the Commission's quote is accurate, and therefore request that it not be used in the Commission's Report.
