Financial Crisis Inquiry Commission Announces Details for Release of Final Report

(Washington, DC) – The Financial Crisis Inquiry Commission will release its report on the causes of the financial and economic crisis on Thursday, January 27, 2011, in Washington, D.C. At the event, the Commission will deliver the results of its inquiry and its conclusions as to the causes of the crisis based on this inquiry. The report with accompanying dissents will be delivered to the President and Congress and will be available to the public that day on the Commission’s website, through the Government Printing Office, and as a paperback and an e-book published by Public Affairs wherever books are sold. In the course of its research and investigation, the Commission reviewed millions of pages of documents, interviewed more than 700 witnesses, and held 19 days of public hearings in New York, Washington, D.C., and communities across the country that were hit hard by the crisis.
